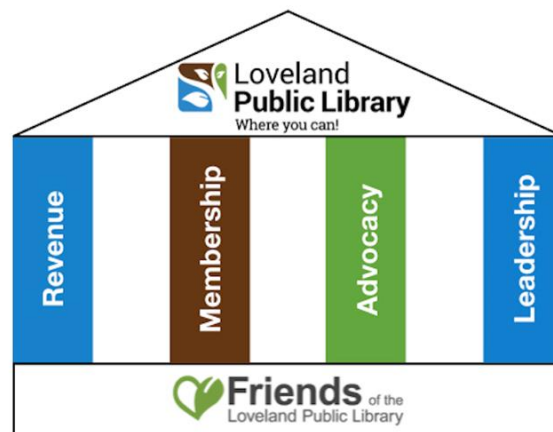

# Committee Reports

## Art in the Galleria

This joint effort among the Friends (ShawnaLee Washam and Sue Baccari), the Loveland Public Library Board (Susan Kadlec and Jennifer Ransburg), and the Library staff (Kathryn Jordan and Esther Hayes along with extreme support from Therese Torpy) provides an opportunity for Colorado artists to exhibit their work, thus serving to raise awareness of Loveland's vibrant arts community among library visitors.

Throughout 2023, members of the Art Selection Committee met to install the four quarterly shows in the Galleria. Additionally, the Committee conversed in July to plan the call for new art, open Aug.-Oct. via the Call for Entry (CAFÉ) website, and met in late November to select artwork for 2024. Library employees worked with the Committee and the City of Loveland legal department to offer contracts to the artists who display in all four quarters of the year. Anticipated in 2024: the library staff will pilot a new program to link the artist's website directly to the library page describing the art in the Galleria display.

All selected artists are featured on the library website and are given the opportunity to sell their displayed artwork. In 2023, five displayed pieces were purchased by patrons in the community with 20% of the proceeds donated back to the Friends. Additionally, an artist donated \$100.00 to the Friends in appreciation for this service to the community.

In 2023, 28 artists and their 65 pieces of art competed for the best of show award. Best of Show for 2023 went to fiber artist Bev Haring in recognition of body of work shown during the year. Susan Kadlec, Library Board member, graciously funded the prize of \$100.00.

## Book Sales

Sales of donated books are our main source of income. These activities promote literacy in the community, and by generating more than half of our annual revenue, provide funding for most of the programming offered by the library. In 2023 we generated over \$116,000 revenue from the sales of donated books!

This year we established a relationship with DreamBooks of Denver, whose mission is to repurpose books. They picked up leftover books from our spring and fall sales with the goal of selling, donating, or recycling them, and we received a small amount of income from their sales.



For the fall book sale, we partnered with Exodus Moving & Storage. They provided trucks and movers to help us move books from the Sorting Place to the Ranch at a discounted rate, and it was wonderful to have professional movers help with the process. We hope to work with them again in the future.



Our Chapter Two bookstore continues to be popular with shoppers, and this year we added evening hours. The store features books in excellent condition, in a variety of categories including children's, teens, adult fiction, cooking, hobbies and crafts, history, and books of regional and seasonal interest. Revenue from the bookstore is once again higher this year than last, and customer feedback has been exceedingly positive and supportive. Stop by and pick up a great book at a bargain price!

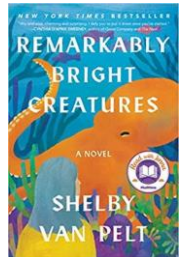
## Business Sponsorship Committee

The Business Sponsorship Committee met monthly to strengthen business contacts, develop marketing strategies, consider new plans, and create a written marketing plan to guide ongoing efforts in working with the Loveland business community. Our contact with the Loveland Chamber of Commerce was enhanced and now offers the ability to market in their weekly newsletters. The committee acquired a new platinum sponsor with the Loveland Good Samaritan Community and a new silver sponsor with FNIC – Trusted Insurance Advisors. Additionally, we continue to work with existing sponsors such as the Weedin Insurance Company and Pam Darling Massage. Committee members represented Friends of the Library at marketing events and hosted a table for membership at the Fall Book Sale that was very successful in acquiring new members.

## Loveland Loves to Read

Loveland Loves to Read is an annual One Book, One Community program. Each year, community members come together through the reading and discussion of a common book. In addition to book discussions, a variety of related events are scheduled.

The Loveland Loves to Read committee hosted an author event with Shelby van Pelt, author of Remarkably Bright Creatures, in April of 2023.



The committee is happy to announce plans to host Luis Alberto Urrea, author of Good Night, Irene, in April of 2024. Urrea is a prolific and acclaimed writer who uses his life experiences to explore themes of love, loss, and triumph. A 2005 Pulitzer Prize finalist for nonfiction and a Guggenheim fellow, he is the author of 19 books, winning numerous awards for his poetry, fiction, and essays.

## Loveland Poet Laureate



The Loveland Poet Laureate Program started off with a bang having received a 2-year, \$5,000 dollar a year grant from the Academy of American Poets for creation of a website that will help us with our program outreach and fundraising. The website is live and functioning at [Lovelandpoetlaureate.org](http://Lovelandpoetlaureate.org).

We participated in the TAAP2D program (Art in Public Places) at the Loveland Public Library obtaining 8 poets to write poetry to the art that is hanging on the walls. We participated and read at the Library's reception along with the Visual Art Commission's chosen artists. It was a great success.

We participated in an ekphrastic response of the Loveland Museum Show of art by Jim Disney. We held a performance in the main gallery and also had 9 poets write poems inspired by the works of Jim Disney. We also held an open microphone reading in the gallery.

We participated in an ekphrastic response to the Loveland Museum Show "New York, New York". We had 8 poets respond to the works on display at the museum. We included musicians and poets in a live roving performance of our works during a reception for the show.

We participated in an ekphrastic response to a museum show entitled: The Flood Ten Years After. We also had a reading and musical performance of all of these poems and others in the Foote Gallery.

We held 4 live Community Performances celebrating the seasons at the Loveland Museum in April, June, October, and December. These included open microphones for the public, music, storytelling, and poetry.

Every 2<sup>nd</sup> Thursday evening we held open microphones at the Black and Blues Music and Brews business downtown. This encouraged many new poets to attend and read their poetry.

In May we brought Rosemerry Wahtola Trommer, former Poet Laureate of Colorado's Western Slope, to the Loveland Museum for a reading and then a workshop the following day in the Devereaux Room. Surrounding her events, we held a special day at the park outside the Museum where we had artists do chalk drawings related to her poetry. Members of the Poet Laureate Advisory Committee created spontaneous poems with accompanying ink drawings for the public. We also had a well-attended open microphone. We had visual art created by several artists in response to her poetry that hung in Black and Blues Music and Brews for 3 months. Rosemerry's performance at the museum included musicians that were playing the lobby of the Rialto during the reception as well as on stage with her in response to her poetry. We were awarded a grant from the Visual Art commission to support the artists.

We held our 4<sup>th</sup> annual High School Poetry Contest. We had planned with this a reading but could not get enough students to attend a community reading. It was a success though with several entries.

In August we had guest Poet Bill Tremblay, Professor Emeritus from CO State University, come from Boston the east coast to present a reading at the Loveland Museum and a workshop at the Loveland Public Library.

In August the Poet Laureate Program Advisory Committee held its first planning retreat to address long term vision for the Program. As a result, we have begun recruiting additional volunteers to serve on subcommittees.

In September we responded to an art exhibit in Art Space for the whole month of September. This included a poetry reading and an artists' talk.

Lynn Kincanon, Loveland Poet Laureate, read at the "Church of Beethoven" at Avogadro's in Fort Collins, with support of the Loveland Poet Laureate program. She did this in collaboration with Steve Denny, a flamenco guitarist.

Four times a year we hold at the Loveland Public Library workshops entitled "Encountering a Poet." We have held 4 of them so far to packed rooms. We have planned 4 more for the first 4 months of 2024.

Starting in early 2023, we began planning to bring internationally known poet Carolyn Forché to the Rialto Theater in April 2024, which is taking up a lot of our time fundraising. She will present an interview-style talk and give a reading of her poems of witness and social justice.

# Library Director's Report

After rebuilding our in-person programming in 2022, the Loveland Public Library worked to build strong ties with the Loveland community in 2023. The Friends of the Loveland Public Library assisted with this community building.



One of the biggest focuses this year for the Loveland Public Library was digital equity. The Library applied for several grants to foster this. The Friends of the Loveland Public Library supported the Library's efforts. The Library received a grant from the Public Library Association (PLA) to provide computer classes in Spanish to the Loveland community. The Library was so successful that we were recognized nationally by the Public Library Association. On October 7, PLA hosted a celebration at the Library to recognize the Library's work. This celebration was attended by over 100 people including Mayor Marsh, Commissioner Shaddock-

McNally, and State Senator Marchman. The Friends of the Library contributed to the success of the event by facilitating a donation of 50 computers from AT&T. These computers were gifts to people who attended the class that accompanied the celebration. With the support of the Friends, 50 people received new computers.

The Friends of the Loveland Public Library has been supporting the Library with a second digital equity grant. The Library applied for a grant for digital navigators through the Colorado Department of Labor and Employment and Colorado Serves (AmeriCorps). We were awarded the \$423,000 grant in May. This will allow the Library to provide one-on-one in-depth digital tutoring. The Friends have worked with Erik Rock to receive a supplemental \$75,000 grant from Comcast. This grant will support the work being done by the digital navigators. The digital navigators can set up a multi-part course for people to learn a new program or digital skill. The patron will be given a device to practice on while the course is going on. If they successfully complete the course, they get to keep the device. The Friends applying for the Comcast grant assures that people are not only learning a new skill but are able to use it on daily basis with a new device.

While the Friends have assisted the Library with our new digital equity endeavor, they have continued to provide support for more traditional programs as well. Our Summer Learning Program continues to be a huge success partially due to the Friend's support. This year kicked off with an event that brought smiles to faces of both children and adults.



Everyone enjoyed the bubble machine and Children's Librarian Andrea Cleland's homemade musical contraption.



The Summer Learning Program had 1770 participants register including children, teens, and adults. Childrens and Teens had a 36% finish rate or 493 kids. Programming was a smash hit with 1450 people attending programs such as the *Summer of Love* or a trip to Hearts & Horses. The Summer Learning Program ended with a joint pizza party between Childrens and Teens. Over 50 pizzas were eaten at the event. The Friends of the Loveland Public Library helped make the Summer Learning Program a hit with their support for the Read Square platform, programs, and summer reading prizes.



This year the Library launched a new community reading event entitled Mosaic. Mosaic is a series of programs surrounding one author's work. Mosaic focuses on diverse voices that the community might not experience elsewhere. This year's author was bestselling Stephen Graham Jones. His works combine horror with indigenous experience. The Friends' support allowed us to do programming such as the Storytellers of the Ancestral Red Road and Chef Andrea Murdoch. These programs allowed adults and children to explore indigenous culture.

The Library celebrated Stephen Graham Jones works with over six different events. Mosaic ended with a wonderful evening with Mr. Jones.

The Friends of the Loveland Public Library work, whether its fundraising or supporting the Library by partnering on grants, continues to help the Loveland Public Library build strong community ties.

As we move into 2024, I am looking forward to the ways that the Friends of the Loveland Public Library can continue to assist the Library in our community building work.

Our 2023 finances were solid. Donations, memberships and net revenue from book sales were up. All library funding requests were supplied and a significant contribution to our reserves was made. The reserves will support needs as Library programs continue to expand, contingencies, and possible support for future capital improvements.

The 2024 budget funds all library requests. The budget assumes two full book sales as well as our ongoing Chapter Two Bookstore and online book sale activities. It also includes a major grant for the Library's technology division.
